## Outdoor Arena and Pavilion are open to the general public 9am-9pm when not reserved.

The Pavilion and Outdoor Arena can be reserved for exclusive use outside of open riding hours. Some usages must be reserved and cannot take place during open riding hours. These include barrel racing clubs, roping clubs, clinics, group lessons, private lessons, etc. Please review all rules posted as you enter the pavilion and inside the west wall of the arena.

**Food Trailer** rental requires additional insurance policy, proof of insurance and required permits. Cleaning list will be provided. Any additional cleaning needed will come out of deposit.

**Arena Heavy Use fee** - if the arena floor has been altered due to a rental, there will be a \$300/day charge until the arena is returned to its original condition. Heavy uses include but are not limited to those that involve motor vehicles.

**Non-agricultural commercial users** will be evaluated on a case by case basis pending Fair Board approval. These uses must not adversely affect local businesses and must provide benefits to the Fair Board's revenue.

Light tokens \$10 each may be purchased at:

- Fairgrounds office, south side of the fair building
- County Clerk's office
- Corner Drug

**Horse stalls** are on the premises and can be rented for \$20per horse per day. See our separate Stall Rental Agreement.

**Dry camping** is allowed on the grounds and must be approved by the fairgrounds office. Camping requests are subject to private rentals and public events. Fees are \$25 per night per rig.
